SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. At Haven Academy's core, we value voice and choice from our entire school community. This includes students, families, staff members and the broader Bronx community of partners. To help us prioritize the allocation of funds from this grant, we conducted a needs assessment and then gathered stakeholder input. Several Family TownHalls were held virtually during the spring and summer of 2021. Additionally, older students, alumni and families were invited in person for a lunch gathering in July 2021 to brainstorm potential allowable fund use. The input from our stakeholders focused on the following areas:

1. Expanding enrichment, arts and afterschool opportunities
2. Expanding intervention opportunities and mental health supports for kids who need extra support
3. Improving offerings and academic support for at-risk students, including special education students.

With this input and feedback, coupled with our internal needs assessment, we have developed the ideas for support requested in this application.

In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

Haven Academy is using a layered approach to mitigation strategies. These layers include all a mask mandate for all staff and students, a full vaccination mandate for all staff, social distancing, the placement of students in pods with no commingling, weekly testing of 10% of staff and students and strict adherence to CDC guidance on exposure, testing and quarantining.

The school has hired a Pediatric Nurse Practitioner to act as the lead in drafting, updating and maintaining its COVID safety protocols. The annual salary for this position is fully covered by the grant for the 2021-22 and 2022-23 school years and partially covered in 2023-24.

Haven Academy thoughtfully uses assessments and data to drive our curriculum development and daily student instruction. Data sources include proficiency levels on interims, norm-referenced benchmark assessments and internal performance rubrics as well as teacher and parent observations and attendance and disciplinary rates. Some assessments used to collect student data include, but are not limited to, i-Ready diagnostic, NWEA Map Assessment, Fountas and Pinnell Reading Assessments, standards based unit and interim assessments, teacher made quizzes and exit tickets. Instructional Staff and Leadership regularly collect and analyze data on individual scholar progress and school wide trends to differentiate instruction, guide daily teaching, and inform areas that require remediation and support. We regularly administer assessments to reassess student interventions and groupings to ensure that students are making adequate growth. Student groupings for both in class instruction and formal interventions are derived from these assessments and data. Special education students' goals are closely monitored using assessment data throughout the year and interventions are adjusted based on the findings. Haven Academy also strategically uses after school programming for interventions and remediation work.

After each assessment, teachers participate in a Data Action Planning (DAP) meeting with leadership and their grade level peers. Using Haven's very specific data protocol, the teams look at grade level, class level, and student level data. The teachers identify what specific standards the students have mastered and what standards still need remediation. After a standard level analysis of the data, the teachers create a Data Action Plan. The DAP addresses specific standards that need remediation, and students are put into small groupings based on their remediation needs. Part of the plan also addresses how and when the teachers will address each group's needs, as well as a date to reassess. Additionally, we look at whole group trends and offer changes to whole class academic routines.

Haven Academy serves a vulnerable population of economically disadvantaged students and children in the child welfare system. In our review of teaching and learning needs, as defined primarily by student achievement data, we recognized that our teachers need ongoing professional development and coaching focused on meeting the special needs of our students. Therefore, ARP-ESSER funding will be used to cover the salary of a staff member who provides ongoing teacher support and coaching. ARP-ESSER funding will also provide funding to help us address learning loss by implementing evidence-based interventions and ensuring that those interventions respond to students' social, emotional, and academic needs. All of our efforts will also be designed to address the disproportionate impact of COVID-19 on underrepresented student subgroups, which is a majority of the school's population.

In addition, Haven Academy will have a longer school day and school year as well as an after school program to further address learning loss, mental health concerns, and to support the needs of our families. Our longer school days and afterschool programming will allow us to offer families options that focus on a myriad of academic, arts, social skills and enrichment options. The longer hours will be used to implement evidence-based interventions.

Haven recognizes that experiences with Covid-19, the school's closure, and shifting to a new way of learning has had a significant impact on all of us. Experiences vary scholar to scholar, family to family and teacher to teacher. It will be difficult to expect teaching and learning to occur during a crisis without attending to our emotions. One thing will be for certain during these times of uncertainty, Social Emotional Learning (SEL) will be the heartbeat of our community-- prioritizing connection to one another and creating a safe virtual experience. Building opportunities to create community and connection will remain vital to all of our interventions as well as finding times to center JOY! Therefore, ARP-ESSER funding will be used to provide mental health services and supports, including the implementation of evidence based full-service community schools and the hiring of counselors.

The remaining ARP funds will prioritize the following allowable expenses:

1. improving indoor air quality
2. planning and implementing activities related to summer learning and supplemental after-school programs.

Mott Haven Academy Charter School (Haven Academy) is an elementary and middle charter school located in the Mott Haven section of the South Bronx, the poorest congressional district in the country. Close to 100% of our students are from economically disadvantaged families. In addition, we reserve one-third of our lottery seats for children in foster care and one-third for children whose families receive at-risk, preventive services. Due to the extreme vulnerability of our student population, Haven Academy regularly reviews multiple data points to assess student need and identify barriers to academic achievement.

All of the data points to an ongoing need for academic and behavioral interventions for a significant portion of our student body. To address these identified needs, Haven Academy offers its students a system of supports and interventions offered to all students at-risk of academic failure. These services include:

- An extended school day and Saturday instruction
- Academic and Behavioral Interventions offered through an RTI framework
- 1:1 and small group remedial instruction
- Reading Phonemic Awareness programs
- Extensive Family Involvement and Support Services

All of these services are provided by qualified and certified teachers and specialists. To ensure that all students are making adequate progress, teachers and instructional leaders regularly gather and analyze student assessment data to identify deficits in skills, personalize instruction, and determine the appropriate level and type of services needed. The school's system of supports and interventions offers a tremendous amount of flexibility and fluidity to enable students to move in and out of service levels, as determined by their individual progress.

On a quarterly basis, the LEA (school) will review its in-person learning plan and operations to ensure that it continues to meet CDC, local and state guidance and assess the data about the school's efforts to minimize virus spread to continue to offer in person learning. The school has established the following protocols for regular review and input:

- Appointment of a LEA based lead medical expert
- Training and identification of school leadership members who form the "situation response team" for cases and communication
- Monthly family TownHalls and/or forums (held in English and Spanish) to address questions and gather input from families on the school's practices
- Regularly established systems for randomized testing at the school to identify asymptomatic cases
